PMF Program Overview

- PMF Program is administered by the U.S. Office of Personnel Management (OPM)
- Program accepts applications annually
 - Rigorous application and competitive assessment process
- Open to all disciplines

- Finalists are eligible to seek appointments as Fellows
 - Two-year fellowship: training and development
- Future leaders in Federal government

PMF Appointment

- Two-year, full-time paid position at a federal agency
 - Initial appointment at the GS-9, 11, or 12 (or equivalent),
 - Promotion potential up to GS-13

- Training and development geared towards target position
- May non-competitively convert to a term or permanent position



Federal Benefits

- PMFs are eligible for the same benefits as most Federal employees:
 - Health and Dental Insurance
 - Paid Vacations, Holidays, and Sick Leave
 - Flexible Spending Accounts
 - Life Insurance
 - Long-Term Care Insurance
 - Retirement Savings Plan
 - Student Loan Repayment Program (varies by agency)



Fellowship

- Program Requirements:
 - Individual Development Plan (IDP)
 - Minimum 80 hours of formal interactive training per year
 - At least one 4-6 month developmental assignment
 - Annual performance plan and performance evaluation
 - Agency-specific requirements, if any
- Additional Opportunities
 - Option to participate in a rotation at another agency
 - Assignment of senior-level Mentor
 - Networking with other Fellows
 - Participation in OPM/PMF Program and agency-sponsored events

Applicant Eligibility

 Graduate students who expect to complete an advanced degree from a qualifying college or university during the academic year (September 1, 2019 - August 31, 2020), or

- Individuals who completed an advanced degree from a qualifying college or university no more than 2 years prior to the opening date of the PMF Program's annual announcement
- U.S. citizenship is not required, but it is "extremely rare" for a noncitizen to obtain Federal employment through the PMF program

- Consists of online application AND online assessment
- 2020 application cycle opens Wednesday, October 3, 2019 at noon Eastern time
- Announcement posted on <u>www.USAJOBS.gov</u>
 - Search using key words "Presidential Management Fellows"
- Before beginning application, be sure to read through all materials under *Become a PMF* (including <u>Application Process</u>) on OPM website
- Prepare ahead of time!

- System requirements and documentation

Application: Required Documents

- Online application includes:
 - Resume

- Transcript and/or alternative (graduate degree)
 - Can be unofficial as long as required elements are included
 - If a required element is missing, submit a letter from the appropriate school official providing the information.
 - UW students can obtain enrollment verification letter that includes your expected graduation date from the Office of the Registrar by following instructions here: <u>https://registrar.wisc.edu/enrollmentverification/</u>
- Supporting documentation for any claims to Native American preference, veterans' preference, and/or reasonable accommodations



Assessment

- Applicants also complete an assessment
 - On-Line Assessment, which includes several batteries
 - Situational Judgment Test
 - Life Experience

- Critical Thinking Skills
- Essay, only one essay compared to two essays last year
- Un-proctored; applicants complete on their own
- Independent work (applicants certify during application)
- PMF website and Guide are the only sources explaining process in detail
 - Each year, as the application period nears, an *Assessment Preparation Guide* is posted under the <u>Assessment Process</u> section of the website



Application Process (summarized)

General application steps:

- Create an applicant account
- Answer demographic questions (optional)
- Answer various bio-data questions (e.g., contact information)
- Answer eligibility questions
- Submit information about degree and school
- Submit documents
- Complete online assessment
- Complete essay
- Answer questions on other degrees, foreign languages, and other skills/attributes (these become searchable for agencies)
- Certify responses and submit application



General Application Tips

General tips for applicants when preparing to apply:

- Resume can be in ANY format, but limited to 3MB in file size
- Leave sufficient time (~3 hours) to prepare, review, and submit
- Male applicants will be asked if registered for Selective Service (<u>www.sss.gov</u>)
- Read the announcement and Become a PMF section on website
 - Avoid relying on third-party information as these are often inaccurate
- Add the following email addresses to "safe list": <u>pmf@opm.gov</u>, <u>pmfapplication@opm.gov</u>, and <u>no-reply@apply.pmf.gov</u>
- Applicants (including Finalists and Fellows) and academia should use the <u>pmfapplication@opm.gov</u>email address
 - Federal agencies and general public should use <u>pmf@opm.gov</u>
- When creating an applicant user account, recommend using a personal email address versus .edu email address



- Finalists invited to participate in PMF virtual career fair
- Finalists search for PMF appointment opportunities on PMF website
- 12 months from the date selected as Finalists to secure appointment with agency and become Fellows
- Employment policies and incentives determined by individual agencies
- All degree requirements must be completed prior to onboarding
- No regulatory provision for waivers/deferrals

- Changes from last year: Applicants will have option to identify their top 5 states they are interested in obtaining a PMF appointment offer
 - Optional question and has no bearing on selection of finalists
 - The information will identify where finalists have geographic interest
 - Applicants will be asked to grant permission to have their application information and documents shared with other federal employers if not selected as finalists



Timeline for the 2020 Application

- October 3, 2019: Application opens at noon (Eastern time)
- October 17,2019: Application closes at noon (Eastern time)
- Week of November 25, 2019: Announcement of the MPF Class of 2020 Finalists
- Week of December 2, 2019: Information webinar for 2020 Finalists
- August 31, 2020: Deadline to complete degree requirements for finalists who acre current graduate students
- Mid to late November 2020: Eligibility deadline for class of 2020 PMF finalists to be hired at an agency
 - Finalists have 12 months to secure an appointment with an agency
